About PCOM: PCOM is a community health and wellness center serving SGM and allies in Baltimore and throughout Maryland. Our dedicated team provides educational, cultural, empowerment, sexual health, and wellness services, welcoming everyone and offering a safe, affirming environment for comprehensive services.

Peer Navigator Overview: The Peer Navigator role at PCOM is pivotal in advocating for the wellness and self-conceptual health of LGBTQ/SGL individuals, families, and allies. Peer navigators, as recognized by the Substance Abuse and Mental Health Services Association (SAMHSA), have a unique capacity to support based on shared experiences. They offer advocacy, guidance, and motivation fostering personal growth, well-being, and health promotion.

The chosen candidate will:

- Deliver client-centered peer support in the Preventive Health clinic and community settings.
- Uphold strict client confidentiality.
- Support clients' health and well-being peer-to-peer, attending appointments as needed.
- Respond effectively during crises.
- Promote client engagement with support services, offering referrals as necessary.
- Provide updated advice on HIV and other sexual health topics.
- Organize and facilitate group workshops.
- Maintain professionalism in interactions with clients, PCOM staff, and other organizations.
- Report on program activities and evaluate the Peer Navigator Program.
- Attend and contribute to regular meetings and service planning activities.
- Educate clients and colleagues on the peer support role.
- Work autonomously and solve moderately complicated problems.

Candidates must have:

- Specialized knowledge in peer support, social work, or similar, gained through experience or training.
- Awareness of sexuality-related stigma.
- Understanding of diverse experiences and identities of sexual and gender minorities.
- Knowledge of PCOM's objectives and working within a community services organization.

Prerequisites:

- A relevant degree with one year of experience, or
- Associate diploma with two years of experience, or
- Lesser formal qualifications with substantial experience, or
- Equivalent expertise and experience from service and/or study.

Organizational Relationships:

• Reports to the Peer Support Manager.

Extent of Authority:

- Exercises a degree of autonomy.
- Manages projects and/or programs.
- Sets priorities and monitors workflow.
- Basic computer skills, including email and Microsoft Word usage.

Salary Range: \$36,000 - \$46,000.
